6.3 Methods and material for containment and cleaning up.

Use soapsuds to detect small leaks. Stop the leak if this can be done safely. Ensure adequate ventilation to prevent the accumulation of gases or vapours.

7.1 Precautions for safe handling.

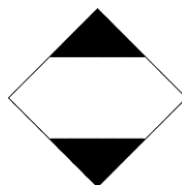
